

ERA Green Hydrogen Fellowships for international Master students • DAAD

Overview

Objective

Climate neutrality by the middle of the 21st century is the declared goal of Germany and the EU. Green hydrogen is an important component in the transformation of the energy sector and the decarbonization of emission-intensive sectors. Within the framework of the German and the European hydrogen strategies, we intend to recruit and qualify future specialists and young scientists. In addition, international cooperation, especially in the European Research Area, shall be strengthened and interdisciplinarity and innovative capabilities promoted. The *ERA Fellowships – Green Hydrogen* programme, funded by the Federal Ministry of Education and Research (BMBWF), is complemented by comprehensive networking measures and the establishment of four working groups. Fellows will continue to be involved in those after the end of the funding period and thus will both receive and offer long-term support from and to the German research and innovation location for green hydrogen.

Who can apply?

Graduate students who are interested in any topics related to Green Hydrogen (GH2) and want to be an active part in one of the four working groups:

- Production
- Transport and Infrastructure
- Market stimulation (i.e. further development of the market for hydrogen)
- cross-cutting issues (i.e. regulation, socio-economic and legal framework)

Students enrolled in universities in the following countries are eligible for the GH2 program: EU member states, Albania, Algeria, Argentina, Armenia, Australia, Bosnia and Herzegovina, Brazil, Cameroon, Canada, Chile, Côte d'Ivoire, Faroe Islands, Georgia, Ghana, Iceland, Israel, Japan, Kosovo, Mexico, Morocco, Republic of Moldova, Montenegro, Namibia, New Zealand, Nigeria, Northern Macedonia, Norway, Serbia, Senegal, South Africa, South Korea, Switzerland, Taiwan, Togo, Türkiye, Tunisia, Ukraine, USA and the United Kingdom.

What can be funded?

The programme provides funding for

- part of a whole Master's degree programme (programmes with 90 ECTS/3 semesters) completed at a state or state-recognised university in Germany

or

- up to one year of study in Germany as part of a Master's degree. The general condition is that the academic credits you gain in Germany are recognised by your home university. Moreover, the standard period of study at your home university should not be exceeded as a result of the study year in Germany

or

- a Master's thesis as part of an international Master's degree programme completed at a state or state-recognised university, a research institute or a company in Germany

or

- a self-organized internship in a German company or at a non-university institution in the field of GH2.

The fellowship grants access to international working groups and allows for active participation and involvement in one group that can

continue after the fellowship ends.

Duration of the funding

Funding for the fellowship programme is available until the end of 2025; Depending on the length of the selected programme, the fellowship is intended for stays of at least 3 months, for a Master's thesis between 2 and 6 months, and for internships between 2 and 3 months.

The fellowships are awarded for the duration of the standard period of study for the chosen programme (up to a maximum of 18 months). Please state the entire period for which you wish to apply for funding in your application. For example, if you are planning a 3-semester degree programme, you must directly indicate 18 months as the desired fellowship duration in your application. After the first year of study, your academic achievements will be assessed in a review process. If this shows that you will successfully complete your programme within a reasonable period of time, the fellowship will continue as planned.

Value

The fellowship covers:

- a monthly fellowship instalment of 934 Euros
- payments towards health, accident and personal liability insurance cover
- a lump sum [https://static.daad.de/media/daad_de/pdfs_nicht_barrierefrei/im-ausland-studieren-forschen-lehren/daad_reisekostenzuschuesse_stipendiaten.pdf] towards international travel costs
- if the fellowship is awarded for more than six months: one-off study allowance (usually 260 Euros; if you come from a [DAC country](https://www.oecd.org/dac/financing-sustainable-development/development-finance-standards/DAC-List-of-ODA-Recipients-for-reporting-2022-23-flows.pdf) [<https://www.oecd.org/dac/financing-sustainable-development/development-finance-standards/DAC-List-of-ODA-Recipients-for-reporting-2022-23-flows.pdf>], you will receive an allowance of 460 Euros)

Under certain circumstances, fellowship holders may receive the following additional benefits:

- if the fellowship is awarded for more than six months: Monthly rent subsidy
- if the fellowship is awarded for more than six months: Monthly allowance for accompanying members of family. - Green Mobility Top Up (Support for climate-friendly travel) or partial reimbursement of carbon offset payments for air travel
- grant for participation in a conference

To allow you to improve your language skills in preparation for your stay in Germany, the DAAD offers the following benefits:

- if the fellowship is awarded for at least twelve months **and** commences in April or October: German language course of 2 months starting in February or August before the start of the study stay in Germany. Participation in a language course is compulsory if the study programme is taught in German. **If you are interested in the participation of a preparatory language course, please indicate this in your application and your schedule.**
- if the fellowship is awarded for more than six months:
 - Payment of course fees for an online German language course after receipt of the Fellowship Award Letter
 - allowance for a personally chosen German language course during the fellowship period
 - reimbursement of the fee for a TestDaF or DSH test, which you can take either in your home country after you have received your Letter of Award or in Germany during your funding period.

Please note that the DAAD does **not** cover tuition fees.

Selection

The selection committees are composed according to subject and, if applicable, regional criteria. The committee members are appointed by the DAAD Executive Board and are primarily university teachers from German universities. They evaluate the applications and decide on the awarding of the fellowships. DAAD staff members organize the meeting but have no voting rights.

The Selection criteria are:

Academic qualification

- Academic achievements
- Course of studies
- Knowledge of the language of instruction or working language
- If applicable, relevant internships, work experience

Quality of the study or internship project

- Quality of the project and of the preparation (preliminary information, choice of degree programme or internship, host university or institution and establishment of contacts)
- Integration of the project into the course of study, if relevant

Potential of the applicant

- Motivation: academic and personal reasons for the stay in Germany, German language skills (if different from the working language)
- Prospects: Significance of the stay in Germany for further academic, professional and personal development, use of international networking in the working groups as well as own active contribution in the working groups
- Extracurricular commitment: extracurricular knowledge and skills, social commitment

In addition, the selection committee will give due consideration to aspects of equal opportunities, on which you can provide information in the application form.

Application requirements

What requirements must be met?

Please check if the following criteria are fulfilled:

- As a rule, your university degree should not date back more than 6 years at the time of the application deadline. Please read our [Important Scholarship Information \[https://www.daad.de/en/study-and-research-in-germany/scholarships/important-information-for-scholarship-applicants/\]](https://www.daad.de/en/study-and-research-in-germany/scholarships/important-information-for-scholarship-applicants/) / Section A, point 2.
- Your application cannot be considered, if you have been resident in Germany for longer than 15 months at the application deadline.

For applicants for a study fellowship:

- Please note that it is your responsibility to ensure that your application for admission to the German university for your selected study programme is submitted by the due date. It is therefore important that you inform yourself about admission requirements, application and enrolment deadlines at your host university and regulations regarding entry into Germany in good time. If you have not yet received notification of admission at the time of application, you can submit this at a later stage, latest by the start of the funding period. A Fellowship Award Letter from the DAAD is only valid if you have been admitted to study at your chosen host university.
- If the degree programme includes a period of study or work placement outside Germany lasting several months, this period abroad is usually only funded under the following conditions:
The study stay is essential for achievement of the fellowship objective, does not take place in the home country, and is no longer than a quarter of the fellowship period. Longer periods cannot be funded, even partially.

For applicants for a self-organized internship:

- Applicants have to be enrolled at their home university.
- Funding is only available from the starting date of the internship.

Language skills

The language of instruction for most study programmes in Germany is German. In international programmes, the language of instruction is English, or both German and English.

Application Procedure

Application deadline

Applications can be submitted anytime from February 12 until April 10, 2024.

The selection meeting will be held in June 2024 and you will be informed about the result of the selection in July 2024. The fellowship can be commenced earliest (at the beginning of each month) from September 1, 2024. If you plan on starting your fellowship later than March 1, 2025, please apply during our next call for applications (in the fall of 2024).

Funding for the fellowship programme is available until the end of 2025.

Application documents

Certificates, proof of credits, certifications and translations may be scanned in non-certified form and uploaded to the DAAD portal. The DAAD reserves the right to request certified copies of the documents.

Documents to be uploaded to the DAAD portal:

- Online application form
- Full curriculum vitae in tabular form (max. 3 pages)
- Study plan including a schedule (max. 3 pages): detailed description of your planned study programme/project/internship in Germany
- If you are planning to do a Master's programme in Germany, you must submit the form "[Information about your preferred master programmes](https://static.daad.de/media/daad_de/word-excel-nicht-barrierefrei/in-deutschland-studieren-forschen-lehren/a206_studiengangsinformation_about_the_study_programme.docx)" [https://static.daad.de/media/daad_de/word-excel-nicht-barrierefrei/in-deutschland-studieren-forschen-lehren/a206_studiengangsinformation_about_the_study_programme.docx]
- Letter of motivation (1-3 pages) which includes a statement about academic and personal reasons for the planned project in Germany **and in which is clearly mentioned in which working group you would like to actively participate**. - Letter of admission to the study programme at the host university or a confirmation by the host institution of your internship in Germany. If you have not yet received notification of admission/confirmation at the time of application, you can submit this at a later stage, latest by the start of the funding period.
- Current overview of grades/ transcript of records with individual grades
- University degree certificate and transcript of records for your last degree programme: the certificate must be subsequently submitted by the time funding starts if you have not yet completed your programme at the time of application.
- Proof of knowledge of language(s) of instruction in the chosen study programme or internship (should not be older than 2 years). Please submit certificates via the DAAD portal even if the university does not require proof of language skills.
- Other documents you think might be of relevance to your application (e.g. certificates of employment, proof of extracurricular engagement)
- English translations of documents submitted in the national language (to be uploaded with the corresponding documents)
- One recent, supporting **letter of recommendation** (previously: 'reference') from a university teacher which provides information about your qualifications. Please regard the instructions given on the tab "Submitting an application".

All application documents have to be submitted in English.

The application procedure occurs online through the DAAD portal.

Please note that the access to the application portal only appears while the current application period is running. After the application deadline has expired, the portal for this programme is not available until the next application period.

Application location

You submit your application via the DAAD online portal, including the letter of recommendation.
